

#### **About Chartered Accountant (CA)**

Chartered Accountancy is a profession that deals with auditing financial statements, accounting, maintaining tax returns, maintaining records of investment, assessment of finance for any individual or firm. Certification of Chartered Accountancy is a professional certification awarded after completion of three examinations namely CA Foundation, CA Intermediate and CA Final.

Chartered Accountant is a someone who has been certified by a statutory organization for there knowledge and skills in accounts. In India Institute of Chartered Accountants of India (ICAI) provides the certification to become a Chartered Accountant

### Benefits Of Becoming A Chartered Accountant

There are various reasons to study the CA course, and be a chartered accountant.

- Chartered Accountants are highly in demand by various organizations including Banks, Financial Organizations, Corporates, etc. So, there are several Job Scopes for Chartered Accountant candidates.
- Candidates with a CA certificate can also start their own auditing firm and start giving auditing services to their clients and CAs are always seen as respectable professionals and are often regarded as highly qualified people.
- Very few individuals are eligible to become CAs due to the difficulty of passing the CA exam, however there is lot of demand but there are fewer persons in this field than there is demand for.
- Candidates with a CA certificate are eligible to take up the carrier in the public and private sector as well as in individual startups.

#### **Levels in Chartered Accountant**

The CA Qualification has been divided into 3 levels:

- CA Foundation Level 4 Papers
- CA Intermediate Level 6 Papers (2 Years Articleship)
- CA Final Level 6 Papers

#### **Exams**

- Paper-based exams are conducted 2 times a year, in the months of May/June and November/December.
- Papers 1 & 2 will be subjective papers with a duration of 3 hrs and Papers 3 & 4 will be objective papers with a duration of 2hrs.

# **CA Passing Criteria**

- Minimum of 40 percent marks in each paper and 50 % in Aggregate.
- It takes 4 to 5 years to complete all the exams & other Training Programmes of the CA course.

## What is an Articleship in CA?

Articleship in Chartered Accountancy is a particular course in this program, that the students need to undergo after the completion of the CA-Intermediate course. The only challenge that comes in front of the students for this articleship course is to choose the perfect place that fits their articleship purpose. As per the CA articleship eligibility criteria, students enrolled in CA foundation course must pass both of the groups in the CA Intermediate course in order to be eligible for CA articleship course. Prior to the commencement of the CA articleship they must also finish the orientation programme and 100 hours of ITT
